## IMC to Provide VA Office of Information & Technology with Enterprise Governance Support

Dulles, VA, 30 October 2019 – [Innovative Management Concepts, Inc. \(IMC\)](#), an information technology services and solutions provider, has been awarded a three-year task order to provide governance support for the [U.S. Department of Veterans Affairs](#) Office of Information & Technology (OI&T) Quality, Performance, and Risk Office. The task order, won through the Transformation Twenty-One Total Technology Next Generation (T4NG) acquisition program, began on 10 September 2019 and will continue into 2021.

As a part of an Enterprise Transformation effort, OI&T is implementing a new IT Governance Framework, founded on the industry-leading Information Technology Infrastructure Library (ITIL) best practices and standards. This ITIL-based Framework is a product of OI&T's collaboration with business partners and industry and was developed by examining VA processes and working with oversight bodies to identify areas for improvement in the current organizational landscape. The IT Governance Framework gives all OI&T senior executives the opportunity to contribute their subject matter expertise to the specialized Governance Board, where they will serve alongside VA business partners. There is one Information Technology Governance Board supported by three councils to provide strategic enterprise oversight.

IMC will provide IT Enterprise Governance support to the Directorate of IT Enterprise Strategic Planning and Governance within the Office of Quality, Performance, and Risk that will include governance engagement, governance management and analysis, consultation and analysis support, and governance administration and support.
